### Mortgages (and how to insure them)

The reverse mortgage is a misnomer when it comes to

mortgages. The term reverse actually refers to the fact that the borrower receives the money from a mortgage loan, and is not required to pay it back until the last borrower leaves the home from death or health care needs. It is intended for borrowers 62 and older only. This class will focus on the relevant rules about reverse mortgages, underwriting guidelines and how to insure them with title insurance.
