LELA INEZ LOGAN, widower, being of competent mind and having the legal capacity to execute this document, as owner transfers on death to **BOBBIE SUE MILLER, RICKY RUDELL LOGAN, KATHY JEAN FISH, AND CHARLENE LYNETTE HIBBS**, as grantee beneficiaries Tenants in Common in equal 1/4th shares, subject to a Life Estate for the benefit of Larry Logan who shall be able to live on the property for the remainder of his lifetime subject to the payment of property taxes and insurance by Larry Logan in the following described real estate, situate in Pushmataha County, State of Oklahoma, to wit:

This transfer is further restricted in that Larry Logan is prohibited from having a female visitor move into the house as long as he remains single, should he get married this restriction is lifted.
