The remaining portion of the presentation will focus on how to market an owner's title insurance policy, which is much more than rehearsing coverages found in the policy or presenting the consumer with a glossy brochure. Instead, this presentation will focus on the fundamentals of persuasion—recognizing the objections that a consumer has to title insurance and presenting the benefits thereof in a way that overcomes those objections.

Every Penny Counts? Or Escrow Gone Wild

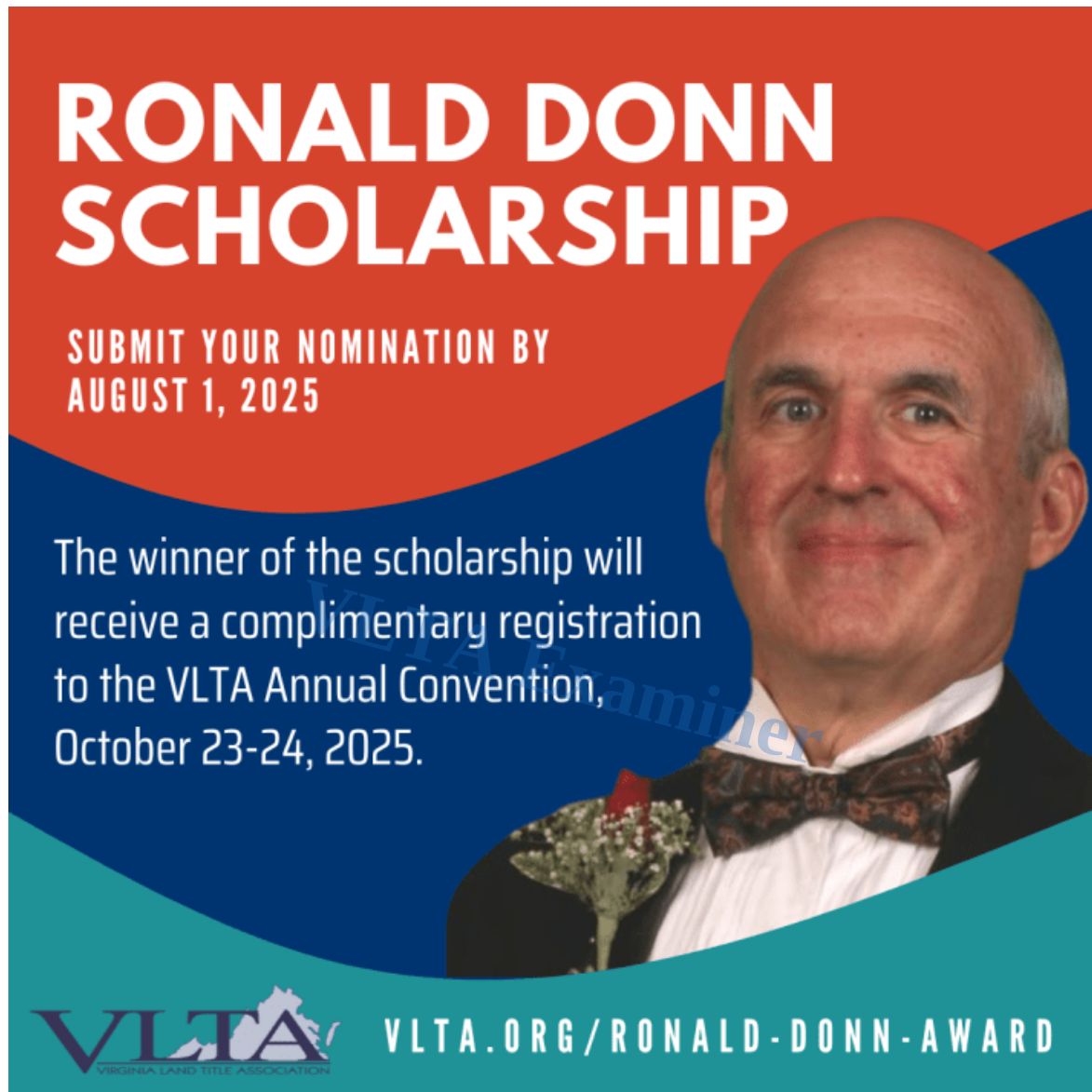
