- [**New Data Reveals Implementation Challenges Under FinCEN Rule**](#)

Significant operational strain, widespread uncertainty and growing concern defined the title industry's experience under FinCEN's Residential Real Estate Rule, according to a new survey from ALTA. The findings reveal that, while companies worked to comply, the rule introduced complex requirements that disrupted workflows, created friction with consumers and raised fundamental questions about responsibility and risk.

The legal battle over FinCEN's Residential Real Estate Reporting Rule is entering a new phase, as Fidelity National Financial Inc. and Fidelity National Title Insurance Co. have formally appealed a federal court ruling that upheld the regulation. In a notice filed April 17, Fidelity is asking the U.S. Court of Appeals for the Eleventh Circuit to review a lower court decision that denied the company's motion for summary judgment and instead ruled in favor of the U.S. Department of the Treasury and FinCEN.

The Financial Crimes Enforcement Network (FinCEN) filed a notice of appeal to a ruling by the Eastern District of Texas that vacated the agency's Residential Real Estate Rule in its entirety. The court found that FinCEN exceeded its statutory authority under the Bank Secrecy Act and ordered the rule be set aside. Meanwhile, ALTA continues to engage with FinCEN and is pushing for more clarity around the rule, urging that any future changes come with adequate notice and a reasonable implementation period.
